2a. Considering aircraft noise starts around 6am and continues until around 11.30pm, leaving approximately 6 1/2 hours available to sleep, should it not be considered at least to restrict aircraft noise to only 'sociable hours', generally accepted as 9am-9pm? It must be accepted that good health, gained through proper sleep and adequate rest is far more important than airport related profits, jobs, or indeed anything else. It should be noted that after noise stops it may take perhaps 30-60 minutes to fall asleep, maybe leaving only 5 hours available. Youngsters and those who prefer to go to bed early, and unable to sleep are severely affected as this disturbance is obviously highly detrimental to their quality of life and health.

2b. Should consideration be given to the restriction of use to only the S/W-N/E runway unless absolutely essential, and thus limit noise pollution only to those unfortunate villages already sadly plagued by noise, instead of adversely affecting the lives of so many thousands of extra residents of villages affected by the use of the other runway? At least then those disturbed remain only those historically affected, and not thousands of others that need not be.
